Stacey Anderson and Lisa Rees Co-owners Love Your Local

- Stacey says there was an estimated 12,000 people in attendance over the whole night. Stacey mentions next time they will get an accurate figure of attendance
- Stacey presents a slideshow of photos and mentions all musicians on the night were local
- Stacey says local businesses were reluctant to be included in the event
- Lisa says the event exceeded their expectation and was a success
- Stacey mentions they had issues with obtaining liquor licences and permits which almost jeopardised the event
- Stacey says for the event to run next year we require more sponsorships and says they will approach SSM again
- Stacey says there was quite a few things identified to work on and improve for the next event - they struggled to get local produce vendors, more seating needed to be available, need to utilise the Mall space and potentially extend the closure of Fryers Street to include Friar's café, more food vendors to decrease waiting times, entry fee –gold coin donation, feedback forms to be distributed on the night
- Malcolm asked what they charged for a site
- Stacey says \$175 for trucks and \$150 for food vendors
- John mentions the possibility of utilising the vacant shops in the Mall for next year's event attempt to sell the space?
- Stacey thinks that is a great idea to discuss for next year
- Sam mentions he was a trader on the night and believes it was very rushed on the day and feels the planning for the set up on the day needs to be more streamlined He suggests the need for road marshal/road officers
- Sam also comments it is a shame Love Your Local did not profit from this event and offers his help in regards to the planning of the next event
